Apartment Listings Definitions:

App Fee: Application fee required by many companies to process

your application.

Deposit: Deposit required to move in and may be refundable when

you move out.

Non-Refundable Refurbishing Fee:

A fee charged to move in that is not in any way refundable

when you move out.

Sec 8: The apartment accepts government housing assistance

programs for those who qualify due to low income.

Accessible Units: The apartment should be accessible with a wheelchair and include

zero entry at threshold, lower countertops and wider minimum 36" doorways. Some apartments may consider an apartment "accessible"

even though it does not meet these minimum standards.
